COMMERCIAL DISCOUNT POLICY AND APPLICATION

Swanson's Nursery is pleased to offer a discount to our qualified business customers. Business discounts apply to the following product categories:

25% discount on Nursery stock (Woody Ornamentals)

15% discount on Perennials.

No discounts apply on any other products or services. Discounts may not be combined with Swanson's promotions (including Swan Dollars), other coupons, or other quantity/volume pricing on the discounted categories. When promotional (sale) pricing exceeds the standard commercial discounts, the higher discount will apply.

Our commercial discount is intended as a courtesy for those professionals working principally in the landscape industry/trade; other businesses will be considered on a case by case basis. To qualify for a commercial discount from Swanson's Nursery please submit the following:

- 1) A current State of Washington Department of Revenue Reseller Permit (if applying for tax exemption) or a Business License, and a completed application.
- 2) If landscape service is NOT the principal business, we may ask for additional information for approval.

If you are also applying for sales tax exemption:

- You must offer all product purchased using this discount for resale to the general public and not for personal use.
- You must submit a current State of Washington Department of Revenue Reseller Permit and you must indicate that you install plants and/or offer other landscape services as your principal business.

Approval for a commercial discount will be given solely at our discretion. For commercial customers with a Reseller Permit, the discount and tax exemption will remain in effect until the expiration of the Reseller Permit. For other commercial customers, the discount will remain in effect until either the expiration date of your business license or one year from the date of the approval, whichever is sooner. A new application will be required to reactivate an expired discount authorization or update tax-exempt status. Please allow two business days for us to process your application.

Swanson's Nursery welcomes your business and is pleased to provide availability and pricing of plants along with this discount. We are not able to include extended assistance in plant selection or landscape design, especially during our peak retail seasons.

This is not an application for credit terms. A copy of your submitted documentation will be kept on file in our offices. We reserve the right to update these policies without prior notice.
